As your City Manager, it is my pleasure to present the San Jacinto 2019/2020 Annual Report. During the past fiscal year, staff has worked diligently and efficiently to deliver on City Council priorities, as highlighted in this report. I am truly proud of the City Staff that have succeeded in finding new ways to continue services during economic uncertainty and in the midst of the pandemic. The Annual Report is a testament to Staff's training, dedication, and ongoing commitment to the citizens of San Jacinto.

As we look forward, our focus continues to be on our City's infrastructure. San Jacinto's legacy is one of change and growth that sparks innovation. We must honor our past by strategically planning for the future. We have spent much of the last year implementing studies, drafting plans, and reorganizing key departments to prepare for future growth of residential, retail, industry and local jobs. New residential development has revitalized defunct projects and has brought long awaited amenities to formerly incomplete neighborhoods (parks, sidewalks, street lights). Our residential development partners have spurred new retail that is turning vacant and forgotten areas into vital shopping resources for our community. With some 1M square feet of new retail opportunities under construction more amenities are on the way.

The Capital Improvement Budget included various high-priority projects, including public utilities infrastructure updates, road projects and improvements; accelerated sidewalk repair and replacement; conversion of high-voltage street lights to a more reliable LED system; lot repaving at the police station, and much needed roof repairs at Fire Station 78; and resurrected a broken down parking lot near City Hall for Library and Main Street use using CDBG funds.

With the guidance and policy direction of the City Council, the City of San Jacinto is poised to enter 2020/2021 in a strong position, and we will continue to further many of the projects and initiatives that began in 2019.


The City of San Jacinto will continue its mission of delivering exemplary municipal services that are responsive to our community and consistent with our history, culture, unique character, and limited budget.






